Dear Sir,

The project that I've proposed for research on elimination of chemicals in agriculture has nothing to do with the topic of your message including Lee Garoyan's conclusions (author's opinion). It is based on the scientific discovery of Ignat Agadjanian and has not analogues in the world. Agadjanian's Information Bulletin for explanation is attached:

CHEMICAL FERTILIZERS LEAD TO NITRATE AND NITRITE POISONING. WHILE THE REAL RESULT PESTICIDES CAUSE IS MORE THAN MILLION DEATH CASES AND MILLIONS OF MAIMED LIVES IN THE WORLD ANNUALLY.
